### Section 4. First aid measures

#### **Description of necessary first aid measures**

Inhalation : Remove

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. #### Small spill

# Precautions for safe handling

# Appropriate engineering controls
