#### **Description of necessary first aid measures**

Inhalation : Remove vic

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. #### Small spill

## Appropriate engineering controls
