#### Section 4. First aid measures

#### **Description of necessary first aid measures**

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention. If unconscious, place in recovery position and get medical attention immediately. Ingestion

#### Methods and material for containment and cleaning up

Small spill

# Section 7. Handling and storage

Precautions for safe handling

# Appropriate engineering controls
