### Section 4. First aid measures

### **Description of necessary first aid measures**

#### Inhalation

: Get medical attention immediately. Call a poison center or physician. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ### Ingestion

### Methods and material for containment and cleaning up

Small spill

### Section 7. Handling and storage

Precautions for safe handling

Conditions for safe storage, including any incompatibilities

# Appropriate engineering controls
