Description of necessary first aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows.
