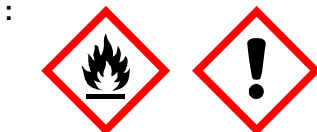

Description of necessary first aid measures

- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. Methods and material for containment and cleaning up

Appropriate engineering controls : Use only with adequate ventilation.
