#### **Description of necessary first aid measures**

Inhalation : R

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. # Appropriate engineering controls
