Description of necessary first aid measures

Inhalation : Remove v

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Methods and material for containment and cleaning up

Small spill

Appropriate engineering controls
