## Section 4. First aid measures

### **Description of necessary first aid measures**

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ### Methods and material for containment and cleaning up

Small spill

## Section 7. Handling and storage

Precautions for safe handling
