#### Section 4. First aid measures

#### **Description of necessary first aid measures**

Inhalation : Remo

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. #### Small spill

#### Large spill

# Precautions for safe handling

# Appropriate engineering controls
